If TTUHSC is being asked to obtain documentation of its Covered Individual's COVIDaccination for a Non-TTUHSC facility site, TTUHSC will accept a CDC COVID vaccination record card or a legible photo of the card, documentation from a health care provider, or a State immunization information system record as proof of COVID vaccination. Proof of vaccination must be provided by the compliance deadlines set forth in the Non-FUHSC Facility COVID Mandate to the TUHSC Office of Institutional Health or campus Designated Health Surveillance Unit event proof of vaccination is unconfirmed, Covered Individuals shall provide acceptable proof of vaccination compliance to the Office of Institutional Health or campus Designated Health Surveillance Unit as may be requested.
